Commercial General Liability Insurance Renewal

Notification of non-renewal of policy received on 2/15/21. Reason cited was two liability claims filed in 2020 totaling \$3,884.00. Policy was due to renew on 6/10/21; Poppell Insurance was contacted to assist with securing new commercial general liability policy.

2021 BOARD ELECTION

Multiple homeowners expressed interest in serving on 2021 Board after the deadline for nominations. Invitations to three interested homeowners to participate as non-voting members of Board were emailed on 1/27/21 requesting a response by 2/12/21. Two responded they will wait until 2022 Board to participate in the election process. No response was received from the third homeowner.

GATE REPAIRS

Safety loops and one control board were discovered non-operational for the exit gate. This may explain the issue with cars being struck by the gate. GateTech installed a new control board which has newer technology and will detect non-operational safety loops in the future. GateTech recommends replacing all seven safety loops as they are original to the system. Each gate loop cost approximately \$650.00. Topic tabled to discuss with other board members.

FRONT ENTRANCE IMPROVEMENTS

The entrance has been pressure washed, repaired and painted. Total cost \$1392.80. Future plans for new mulch, tree trimming and landscaping are in the works.
