# Southwest Florida Water Management District inspection of our water management systems due by 6/10/2018

- George Granger contacted SWFWMD and discussed our current standing water issue. They
  recommended that one of us be present during the inspection and identify the issues to the
  inspector. If needed, have the inspector request a 90-day extension from SWFWMD to allow us
  time to correct the issue.
- Requested and received quotations from three engineering companies to perform the required inspection;
  - Validus Engineering Group 900.00
  - Kinney Engineering 375.00
  - o Boggs Engineering 410.00
- We selected Boggs considering;
  - They are already familiar with our area and also the water management issue we are currently experiencing. They will not be surprised by anything.
  - Sinney Engineering are not familiar with our area and their proposal seems to allow some wiggle room for them to request additional charges based on unknowns they encounter. This also risks delay pushing us beyond the due date 6/10
  - o The cost of 35.00 over Kinney Engineering is not material.

- Boggs performed the inspection 5/23/18;
  - We expect their report soon.
- Action Charles get input from George on result from survey's and inspection and possible next steps

### **Gate Repairs Update**

- Tim reviewed Gate Tech invoices, identified rental for the circuit board that we shouldn't be paying. Gate tech agreed to give us a credit for it.
- Since replacing the circuit board with a new one and a surge protector we are unable to program the gate with new codes, numbers, etc., due to noise on the line. Gate Tech said this often occurs when a surge protector is used. We prefer not remove the surge protector as this risks damage to the new board.
- Tim is working with Frontier for a solution to noise on the line.

o Awaiting feedback from George on options for re-sealing the road.
