## **APPROVAL OF MINUTES**

## August 2012 Board Meeting Minutes

 Motion by Drew made to reject August 2012 minutes as they failed to record discussion related to blue carriage lights. Motion seconded by Al. Unanimous vote in favor of rejecting minutes. Motion made by John to amend minutes, seconded by Drew to include blue carriage light discussion. Motion by Tiffany, seconded by Drew, to approve amended August 2012 minutes to include the text below.

"During the HOA Board meeting held on August 15th, a discussion about a homeowner burning blue carriage lights and a complaint lodged about the inconformity of such was inadvertently not properly recorded in the official board meeting minutes. This discussion was not included on the meeting agenda and was overlooked when capturing the meeting minutes.

Kay Green, Architectural Committee Chair, noted that the Architectural Committee did discuss the color of bulbs in carriage lights as a design standard and voted as a committee to not establish a standard and prefers to not set a precedent by adding more restrictive design standards based a single complaint; further, the Architectural Committee does not believe a carriage light bulb color restriction falls within the intent of our Deed Restrictions.

The board was in agreement with the Arch Committee's decision to not restrict carriage light bulb colors so no change in policy or procedure was necessary. There was no vote or motion on the subject. All board members present supported leaving the authority of what to establish a design standard around with the Arch Committee."

- Al contacted 5 fence contractors. 2 responded
- Al met with Danielle Fence and Gate Tech
  - Gate Tech estimate \$3494
  - Danielle Fence estimate \$3991
  - Both vendors created similar draft designs
  - Gate Tech
    - Shorten existing gates 5 ft each and install heavy duty 2000lb hinges, powder coat gate
    - Install 6" x10' x 1/4 wall powder coated gate posts set 4' in from columns and two in center of drive
    - Relocate existing gate operators to shorten gates, replace clutch assemblies on operators
    - Ornamental fence panels to fill areas between 6"
  - ACTION: All to provide both quotes and details to present at general meeting
  - o **ACTION**: Bob to post both quotes on website for community review
